## BOAT PARKING

---

### PREAMBLE

In our quest to further simplify and streamline the tracking of boats / equipment kept at HYC, we have created new ID discs that have unique numbers; from 1<sup>st</sup> September 2010 these must be displayed on each and every item of boating equipment belonging to you e.g. boats, canoes, tenders, dolly's, masts, centre-boards, rudders, trailers, sailboards etc. This will assist us in identifying all boating equipment on the club premises. THESE ARE ISSUED FREE OF CHARGE.

This Regulation is designed to cut the hassle and instil direction and clarity to the matter of Boat Parking and thus make the process more acceptable and enjoyable for the members.

One of the aspects considered was the necessity of facilitating the parking of the Keelboats in the Car Park area during the winter months as it is impractical to park them on the upper Park. This results in the space all being used up and will require the small yachts, and Power Boats, to be moved to the upper Boat Park during this period.

Another aspect considered was the necessity to have some order in the allocation of parking space on the hard and alongside the Club.

### REGULATION

1. Certain craft attract annual boat parking fees, a season disc reflecting the current season needs to be displayed on the these craft next to the ID Disc indicating the fee has been paid/ invoiced. Please check the fees as per the latest list on the website <http://www.hyc.co.za/membership.php> All boats parking on the Club premises shall have paid the appropriate Boat Parking/Mooring fee and display the approved and up to date season disc as well as the new ID disc (Dinghies and Multihulls on the port rear transom)
2. Boat Parking and Mooring season discs may be obtained from the Club Manager, after completing the required application form which shall be submitted through the Manager to the Sailing Committee for consideration before boat parking is allocated. Please complete the Boat Parking form and hand to the Manager with cash payment or fax / email back which will result in an invoice being sent to you for payment. Once you have returned your form as above you must collect the discs from the Manager's office. Please note this fee is due on ALL the boats you store anywhere on the club's premises.
3. **MOST IMPORTANT!! All boats and equipment must display these ID and season discs by 15<sup>th</sup> October in any given season**, otherwise boats and equipment not identified by then will be removed to the top of the club's premises at the owner's risk and later auctioned.
4. Please note bylaw 8.1 (h) of the HYC Constitution, 8.1 General: h) Boats and trailers may not be stored on sites during the sailing season.
5. On the Hard Dinghies shall only park in the bay allocated to them.
6. Dinghies and Multihulls shall be securely tied down when parked.
7. Keelboats shall not be permitted to park in the Car Park area after 15 October unless they are under repair and the owner has applied to the Manager and been granted permission in writing from the Sailing Committee.
8. Boats under repair as envisaged above may not remain;
  - In the lifting frame for more than two consecutive weekends
  - In the parking area for more than 30 days
9. Boats under repair for longer than 30 days must be parked in the marked area on the top terrace.
